TERMS AND CONDITIONS OF USE

The Club agree to provide a space within the Club property to be allocated by the Club for the storage of the Member's boat. Storage of boats is only available to **full members**, i.e. not available to social or associate members.

The period of the agreement shall be for

1. 'Seasonal storage', i.e. six months winter storage for Yachts or six months summer storage for Dinghies and Catamarans.
2. 'Year-round' storage. Year-round storage will include payment for a cradle or trailer. However, if a cradle or road trailer is left in the compound all year whilst the boat uses 'seasonal' storage then a cradle fee should be paid.

Storage fees are currently £3 per foot for 'seasonal' storage and £6 for 'year-round' storage, measured to the next whole foot of overall length or standard lengths as below. (Fees as at 01/01/2018)

Collection of fees will be done annually aligned with the membership year via the annual membership renewal form. Any short term or unforeseen use of the compound will be invoiced separately.

Boat owners are required to respect the seasonal operation of the compound.

1. In summer Yachts which have been overwintered in the lower compound must be moved to enable dinghies and catamarans to occupy the spaces nearest the lower gates. Yacht owners launching their yacht in the springtime must also ensure that their cradle is removed from the lower compound. Space is available in the upper compound for cradle storage.
2. Dinghy owners who have occupied the lower compound for the sailing season must move their boats from the south and east fences of the lower compound at the end of the season so that yachts can be lifted from the water directly into the compound to overwinter.

All boats must be clearly named with the name displayed on the boat, trailer, yacht cradle, and other equipment associated with the boat.

In the interest of the club the Management Committee reserve the right to restrict access and amend storage fees for unusually designed boats.

Boat owners must contact the compound supervisor (Harky Hutchison 07748973640) in advance to agree space and positioning.

NON-PAYMENT OF FEES/ ABANDONED BOAT POLICY

If at any time, any fees payable to the Club by a member or former member shall be three months or more in arrears and a vessel, the property of such a member or former member remains upon the Club premises, the Committee may: -

1. Move the boat to any location within the compound without being liable for any loss or damage to the vessel howsoever caused.
2. Give three months' notice in writing to the member or former member at his/her last known address as shown in the Club records and thereafter sell the vessel and deduct any monies due to the Club (whether by way of arrears of subscription or compound fees, or otherwise) from the proceeds of sale before accounting for the balance (if any) to the member or former member.

The club shall be under no obligation to achieve true market value of any boat sold during the sale process to recover funds owed to the Club.

If a Vessel is sold while stored in the Club compound.

The seller of the vessel shall be required to inform the Committee of the sale within one week of the completion of the sale. If the vessel is sold:

1. To a Member – then that Member shall be entitled to leave the vessel at the Club compound until the expiry of the storage period on condition that he/she signs the appropriate contract.
2. To a non-Member – then the non-member must remove the vessel from the Club compound/grounds as soon as is possible, and under no circumstances may they do any fitting out on the vessel. Vessels must not be removed until storage has been paid for in full. Alternatively, they may apply for membership of the Club, and upon being accepted after appropriate payment, then apply for a new agreement for storage of the vessel.
3. It shall not be competent for the previous owner to assign, sell, or in any other way transfer his/her rights and obligations under their Agreement (compound storage) without the consent of the Committee.
